DEDICATION AGREEMENT

THIS DEDICATION AGREEMENT is made and entered into this 12TH day of November, 2015, by and between UTAH TRANSIT AUTHORITY, a public transit district organized under and pursuant to the laws of the State of Utah ("UTA"), and SALT LAKE CITY, a municipal corporation of the State of Utah (the "City"), individually and collectively known as a Party or Parties.

WHEREAS, pursuant to and in connection with that certain "Interlocal Agreement Regarding the Design and Construction of the Downtown to Airport TRAX LRT Project" dated as of June 12, 2008, UTA has constructed and is operating a light rail line known as the Airport Light Rail Line ("Airport LRT") to provide light rail public transit in and around Salt Lake City, Utah, between downtown Salt Lake City and the Salt Lake International Airport; and

WHEREAS, in connection with and in preparation for the construction of the Airport LRT, and in cooperation with the City, UTA did purchase certain properties along the Airport LRT corridor, to facilitate space for the Airport LRT transit facilities and related appurtenances, together with City betterments, facilities and appurtenances; and

WHEREAS, UTA now desires to convey to the City those properties that are or are to be within the City's public right of way, as sidewalk, curb, gutter, and other public rights of way (the "Properties") and the City desires to accept dedication and ownership of the Properties.

NOW, THEREFORE, on the stated Recitals, which are incorporated herein by reference, and for and in consideration of the mutual covenants and agreements hereafter set forth, and for other valuable consideration, the receipt and sufficiency of which the parties acknowledge, it is hereby agreed as follows:

1. Dedication. By execution hereof, UTA does hereby dedicate, convey and quitclaim title to the Properties to the City. The Properties are further specifically described in

Exhibit "A", attached hereto and by this reference made a part hereof. By execution hereof, the City does hereby accept dedication of and title to the Properties.

2. Maintenance. From and after the date hereof, the City, by virtue of having accepted dedication of and title to the Properties, does hereby accept full responsibility for any maintenance of the Properties, as necessary or required in the City's sole discretion.

3. Liability for Acts Prior to Execution. UTA and the City are governmental entities under the Governmental Immunity Act of Utah, *Utah Code Ann. § 63G-7-101, et seq.* To the extent not inconsistent with the terms of the Act, each party is responsible for wrongful or negligent acts committed by it or its agents, officials or employees on or related to the Properties prior to the date hereof. UTA and the City do not waive any third-party defenses otherwise available under the Act, including specifically the liability limits set forth in the Act.

4. Miscellaneous. This Agreement will be governed by and construed in accordance with the laws of the State of Utah. Enforcement of the terms and conditions of this Agreement will be strictly reserved to the parties hereto, and nothing contained in this Agreement will give or allow any claim or right of action by any third person. This Agreement may not be amended except in a writing signed by both parties.
