

CORAL WILDE, a widow, of Granger, County of Salt Lake, State of Utah, Grantor, hereby CONVEYS and WARRANTS to LEO O. FRAZIER and ROBERTA H. FRAZIER, his wife, as joint tenants and not as tenants in common, with full rights of survivorship, Grantees, of Oakley County of Summit, State of Utah, for the sum of Ten and no/100 (\$10.00) Dollars, and other good and valuable consideration, the following described tracts of land situated in Summit County, State of Utah:

Parcel 1: Beginning at a point 10.5 chains North and East 12.342 chains, and North 279 feet from the Southwest corner of Section 20, Township 1 South, Range 6 East, Salt Lake Base and Meridian, and running thence West 154.572 feet; thence South 126 feet; thence West 7.428 feet; thence North 39 feet; thence West 190.572 feet; thence North 435 feet to the North line of the Southwest quarter of the Southwest quarter of said Section 20; thence East 352.572 feet; thence South 348 feet to the place of beginning.

Parcel 2: Beginning at a point 30 rods East from the Southwest corner of the Northwest quarter of the Southwest quarter of said Section 20, and running thence East 23 rods; thence North 11 rods; thence Southwesterly in a direct line to a point 3 rods north of the place of beginning; thence South 3 rods to the place of beginning.

EXCEPTING from the second parcel the portion thereof within the highway right of way.

There is expressly excepted from the warranty hereunder the west 62 feet of the north 277 feet of parcel 1 and the west 33 feet of the south 150 feet of said parcel 1, and as to such land the effect of this deed is a quitclaim only.

Parcel 1 contains 3.65 acres, exclusive of the quitclaimed portion thereof, and Parcel 2 contains 1 acre, more or less, including the portion thereof within the highway right of way.

Together with the improvements thereon and the water and water rights appurtenant to said land and used upon or in connection therewith, particularly including 4 shares of New Field & North Bench Irrigation Company stock.
