

A parcel of land situate in and extending across the South one-half (1/2) of Section 9, and the Southwest quarter of Section 10, and the North one-half (1/2) of Section 15, Township 5 South, Range 1 West, of the Salt Lake Bose and Meridian, in the County of Utah, State of Utah, bounded and described as follows:
