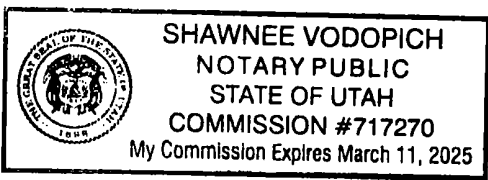

Please allow this letter to serve as documentation of the care that Mr. Whipple has received through the VA Salt Lake City Neurology department.

Mr. Whipple was first seen in Neurology January 2021 for progressive cognitive decline. He was most recently seen in Neurology 04/30/2021.

Mr. Whipple presents with severe dementia, and a score of 5/30 on the Montreal Cognitive Assessment (MoCA). He presents with functional decline requiring complete assistance with all IADLs. He can physically complete many ADLs, however does require verbal direction with things such as getting dressed. During most recent clinic visit, he presented with even worsening dementia to include agitation, anger outbursts, leaving the house unsupervised, and trying to get out of a moving vehicle.

Veteran has been referred to the VA Salt Lake City Geriatric Clinic for continued interdisciplinary management of his care needs.
