AN ORDINANCE VACATING the west 125 feet of Fuller Avenue, running East from 10th East Street.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That the west 125 feet of Fuller Avenue, running east from 10th East Street, more particularly described as follows, be, and the same hereby is, vacated and declared no longer to be public property for use as a street, avenue, alley or pedestrian way:

Beginning at the Northwest corner of Lot 3, Block 20, Plat "F", Salt Lake City Survey, and running thence North 33.0 feet; thence East 125.0 feet; thence South 41.0 feet; thence West 125.0 feet; thence North 8.0 feet to the point of beginning.

Said vacation is made expressly subject to all existing rights of way and easements of all public utilities of any and every description now located on, in, under or over the confines of the above described property, and also subject to the rights of entry thereon for the purpose of maintaining, altering, repairing, replacing, removing or rerouting said utilities and all of them.

Passed by the Board of Commissioners of Salt Lake City, Utah, this 15th day of August, 1973.
