 to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns and
 licensees, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual
 easement and right of way for the erection and continued maintenance, repair, alteration, and replace-
 ment of the electric transmission, distribution and telephone circuits of the Grantee, and
Two Poles and One Guy Anchor, with the necessary guys, stubs, crossarms and
 other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and
 maintained on, under, upon and across the premises of the Grantor.S., in Utah County,
 Utah, along a line described as follows:

Beginning at the east boundary fence of the Grantor's land at a point 330
 feet south, and 1155 feet west, more or less, from the east one quarter corner
 of Section 26, T. 6 S., R. 2 E., S.L.M., thence S.89°52' W. 66 feet, to the
 north boundary fence, and being in the NE 1/4 of the SE 1/4 of said Section 26.

Beginning at the north boundary fence of the Grantor's land at a point
 332 feet south, and 1295 feet west, more or less, from the east one quarter
 corner of Section 26, T. 6 S., R. 2 E., S.L.M., thence S.1°31' E. 173.5 feet
 on said land and being in the NE 1/4 of the SE 1/4 of said Section 26.
