The State of Utah, through and by its State Land Board, by its duly appointed, qualified and acting Executive Secretary, Grantor of Salt Lake City, in the County of Salt Lake, State of Utah, hereby Quit-Claims to Horace M. Seal, Grantee, of Lark, County of Salt Lake, State of Utah, for the sum of One Thousand Nine Hundred Fifty and no/100 (\$1,950.00) Dollars and other good and valuable considerations, all its right, title and interest in and to the following described tract of land in Salt Lake County, State of Utah, to-wit:

Beginning at the Southeast corner of the Northwest quarter (NW<sup>1</sup>/<sub>4</sub>) of the Mortheast quarter (NE<sup>1</sup>/<sub>4</sub>) of Section Thirty-two (32), Township Three (3) South, Range One (1) West, Salt Lake Meridian; and running thence North Thirty (30) rods; thence West One Hundred Sixty (160) rods; thence South Thirty (30) rods; thence East One Hundred Sixty (160) rods to the place of beginning, being the South Thirty (30) rods of the Northeast Quarter (NE<sup>1</sup>/<sub>4</sub>) of the Northwest quarter (NW<sup>1</sup>/<sub>4</sub>) and the South Thirty (30) rods of the Northwest quarter (NW<sup>1</sup>/<sub>4</sub>) of the Northeast quarter (NE<sup>1</sup>/<sub>4</sub>) of said Section Thirty-two (32), containing Thirty (30) acres, together with any and all buildings, improvements and appurtenances thereunto belonging.
