WARRANTY DEED OF EASEMENT

WEHER BASIN WATER CONSERVANCY DISTRICT, a public corporation of the State of Utah, with its principal place of business at Ogder, Weber County, State of Utah, Grantor, hereby conveys and warrants to THE UNITED STATES OF AMERICA, acting pursuant to the provisions of the Act of June 17, 1902 (32 Stat. 388), and acts amendatory thereof or supplementary thereto, Grantee, for the sum of One Hundred Sixty-two and no/100 Dollars (\$162.00), the following described real estate in the County of Davis, State of Utah:

A perpetual easement to construct, reconstruct, operate and maintain an underground pipeline and appurtenant structures including a blowoff structure, which will protrude above the ground surface, together with a road for operation and maintenance of said pipeline on, in, over or across the following described property:
