EOW, THEREFORE, the United States acting pursuant to the Act of Congress of June 17, 1902 (32 Stat. 388) having completed the construction work of the Davis Aqueduct and appurtenant structures through the certain easement area, does hereby release, terminate, and discharge the temporary easement obtained from the Grantor named in that certain deed dated December 31, 1954, and recorded in Book 77, Page 632, on the 21st day of January 1955, in the Davis County Recorder's Office and described as follows:

A strip of land in the Mortheast Quarter of the Southwest Quarter (NE\*SW\*) and the Morthwest Quarter of the Southeast Quarter (NW\*SSE\*) and Section Thirty-six (36), Township Four (4) North, Range One (1) West, Salt Lake Base and Meridian, Two Hundred Ten (210.0) feet wide and included between two lines extended to the property lines and everywhere distant One Hundred Ten (110.0) feet on the right or Westerly side and One Hundred (100.0) feet on the left or Easterly side of that portion of the following described centerline of what is known as the Devis Aqueduct from Station 374+16.0 to Station 375+00.0 measured at right angles thereto; and One Hundred Fifty-five (155.0) feet wide and included between two lines extended to the property lines and everywhere distant Ninety (90.0) feet on the right or Westerly side and Sixty-five (65.0) feet on the left or Easterly side of that portion of said centerline from Station 375+00.0 to Station 377+28.6 measured at right angles thereto; said centerline is more particularly described as follows:

Beginning at Station 374+16.0, a point on the North line of the Grantor's property, from which point the South Quarter corner of said Section 36 bears South 1°08' East Twenty-one Hundred Eighty-three and Six-tenths (2183.6) feet, and running thence South 25°32' East Three Hundred Twelve and Sixtenths (312.6) feet to Station 377+28.6 of said Aqueduct centerline, a point on the South line of the Grantor's property, from which point the South Quarter corner of said Section 36 bears South 2°46' West Mineteen Hundred Three and Four-tenths (1903.4) feet, containing 1.2 acres, more or less, excepting herefrom 0.3 of an acre, more or less, which is covered by a perpetual easement and described as follows:

A strip of lead is to Quarter (BEAST) and cost Quarter (BEAST) Meridian, Forty (40.0) feet wide lines extended to the property 11 Twenty-five (25.0) feet on the right or Wasterly Fifteen (15.0) feet on the left on Easterly side portion of the following described centerline of what is known as the Davis Agneduct from Station 374+16.0 to Station 377+28.6 measured at right angles thereto; said centerline is more particularly described as follows:

Beginning at Station 374+16.0, a point on the North line of the Grantor's property, from which point the South Quarter corner of said Section 36 bears South 1°08' East Twenty-one Hundred Eighty-three and Six-tenths (2183.6) feet, and running thence South 25°32' East Three Hundred Twelve and Sixtenths (312.6) feet to Station 377+28.6 of said Aqueduct centerline, a point on the South line of the Grantor's property, from which point the South Quarter corner of said Section 36 bears South 2°46° West Nineteen Hundred Three and Four-tenths (1903.4) feet.
