EASEMENT

Samuel G. Raymond, Inc. a corporation doing business in the State of Utah, Grantor, hereby conveys to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection, operation and continued maintenance, repair, alteration, inspection, relocation and replacement of the electric transmission and distribution circuits of the Grantee, with the necessary poles, towers, guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said circuits, on, over and across a tract of land located in Davis County, Utah described as follows:

Two guy anchors located on the Grantors' land at a point 510 feet north and 570 feet east, more or less, from the south one quarter corner of Section 36, T. 4 N., R. 1 W., S.L.M. and being in the SW 1/4 of the SE 1/4 of said Section 36.
