## RIGHT OF WAY AND EASEMENT GRANT

The land of the Grantor located in the Northeast quarter of the Northwest quarter of Section 27, Township 6 North, Range 1 West, Salt Lake Base and Meridian;

the center line of said right of way and easement shall extend through and across the above described land and premises as follows, to-wit:

Beginning at a point 853.65 feet North and 121.73 feet East from the Southwest corner of the Northeast quarter of the Northwest quarter of said Section 27, thence North 22° 07' 48" East 99 feet, thence North 7° 52' West 33 feet, more or less, to the North line of Grantor's property.

TO HAVE AND TO HOLD the same unto the said Mountain Fuel Supply Company, its successors and assigns, so long as such facilities shall be maintained, with the right of ingress and egress to and from said right of way to maintain, operate, repair, inspect, protect, remove and replace the same.
