RIGHT-OF-WAY EASEMENT

The Undersigned Grantor (and each and all of them if more than one) for and in consideration of ONE DOLLAR (\$1.00) in hand paid by the Grantee, the receipt whereof is hereby acknowledged, hereby grants, bargains and conveys unto The Mountain States Telephone and Telegraph Company, a Colorado corporation, 931 14th Street, Denver, Colorado, 80202, Grantee, its successors, assigns, lessees, licensees and agents, a Right-of-Way Easement and the right to construct, operate, maintain and remove such communication and other facilities, from time to time, as said Grantee may require upon, over, under and across the following described land which the Grantor owns or in which the Grantor has any interest, to-wit: A five foot (5') easement, the South line being as follows: Beginning at the Southeast corner of the Northeast Quarter of the Northwest Quarter, Section 27, Township 6 North, Range 1 West, Salt Lake Base and Meridian, U. S. Survey; running thence East 342.89 feet. Also, a five foot (5') easement being 2.5 feet on either side of a buried telephone facility over the following described property per the Mountain States Telephone & Telegraph Company Drawing # U-3-5111: Beginning 415 feet North of the Southwest corner of the Northeast Quarter of the Northwest Quarter of Section 27, Township 6 North, Range 1 West, Salt Lake Base and Meridian, U. S. Survey; running thence North 460 feet to the South line of Valley Drive; thence North-easterly along Valley Drive 690 feet more or less; thence North 7 feet; thence North-easterly along Valley Drive 640 feet; thence South 230 feet; thence West 260 feet; thence South 320 feet; thence West 390 feet; thence South 455 feet; thence North 64°54' 04" West 390 feet; thence North 72°54'45" West 319.61 feet more or less to the beginning. situate in County of WEBER, State of UTAH.

TOGETHER with the right of ingress and egress over and across the lands of the Grantor to and from the above-described property, ~~the right to clear and keep cleared all trees and other obstructions as may be necessary and the right to permit other utility companies to use the right-of-way jointly with Grantee for their utility purposes.~~

The Grantor reserves the right to occupy, use, and cultivate said property for all purposes not inconsistent with the rights herein granted.
