A RESOLUTION OF THE BOARD OF TRUSTEES OF THE SALT LAKE VALLEY FIRE SERVICE AREA CHANGING THE NAME OF THE SALT LAKE VALLEY FIRE SERVICE AREA TO THE UNIFIED FIRE SERVICE AREA

WHEREAS, the Salt Lake Valley Fire Service Area was duly created by the County Council of Salt Lake County to provide fire suppression and emergency services to the unincorporated area of Salt Lake county;

WHEREAS, the cities of Riverton, Herriman and Midvale, located in Salt Lake county annexed to the Service Area;

WHEREAS, the city of Eagle Mountain, located in Utah county, has annexed to the Service Area thus expanding its geographical jurisdiction into two counties;

WHEREAS, the expansion of the Service Area into Utah county necessitates a change in the name of the Service Area to one that properly reflects the geographical scope of its jurisdiction; and

WHEREAS, the Service Area is a member of the Unified Fire Authority, an interlocal entity that provides fire suppression and emergency services on behalf of its members and is thus identified with its members.

NOW, THEREFORE, the Board of Trustees of the Salt Lake Valley Fire Service Area has determined that it is in the best interests of the Service Area to change the name of the Service Area to one that reflects the geographical scope of its jurisdiction and its affiliation with the Unified Fire Authority and accordingly hereby changes the name of the

Service Area to the "Unified Fire Service Area". The Clerk of the Service Area shall provide copies of this Resolution to the Lieutenant Governor, Utah State Tax Commission and the Salt Lake County Assessor and further shall record a copy of this Resolution in the office of the Salt Lake County Recorder. The Clerk is further directed to file an amended Governmental Immunity Act Registration with the Utah Division of Corporations and Commercial Code.
