Sommer, Grantors, of Peoria County of Peoria, State of Illinois, hereby convey and warrant to Henry ~~Faunce~~ Truckenbrod, Grantee, of the County of Box Elder, State of Utah, for the sum of Six Thousand One Hundred and Sixty Dollars (\$6160.00), the following described tract of land in Box Elder County, State of Utah, to-wit:

The South one-half (1/2) of the Southeast quarter (1/4) of Section Nine (9), Township Eleven (11) North, Range Three (3), West Salt Meridian, reserving therefrom a strip of land two (2) rods wide, running along the east and south sides, for road purposes, containing exclusive of said road, seventy-seven acres, more or less. 




