



Valley-West Baptist Church and Sonrise Baptist Church, corporations organized under the Utah Non-Profit Corporation and Co-operative Associations Act (the "Act"), hereby execute the following Articles of Merger pursuant to Section 16-6-57 of the Act:



ARTICLE I.

The names of the corporations proposing to merge and the date of incorporation of such corporations are as follows:

ARTICLE II.

The name of the surviving corporation is Sonrise Baptist Church.

ARTICLE III.

The Articles of Incorporation of the surviving corporation shall be the Articles of Incorporation of Sonrise Baptist Church, as amended by the Agreement and Plan of Merger attached hereto as Attachment A (the "Plan of Merger").

ARTICLE IV.

The Plan of Merger was approved and adopted in the manner prescribed by the Act on February 27, 1994, at a duly held meeting of the members of Valley West Baptist Church, at which meeting a quorum was present, by at least a two-thirds majority vote of the members present at such meeting or represented by proxy.

ARTICLE V.

The Plan of Merger was approved and adopted in the manner prescribed by the Act on February 27, 1994, at a duly held meeting of the members of Sonrise Baptist Church, at which meeting a quorum was present, by at least a two-thirds majority vote of the members present at such meeting or represented by proxy.

ARTICLE VI.

Valley West Baptist Church and Sonrise Baptist Church have complied with all applicable provisions of the law of the State of Utah relating to the merger.

ATTACHMENT A

PLAN AND AGREEMENT OF MERGER OF VALLEY WEST BAPTIST CHURCH INTO SONRISE BAPTIST CHURCH

THE PROPOSED MERGER

- 1. Merger. Valley West Baptist Church shall be merged into Sonrise Baptist Church in accordance with all applicable provisions of the Utah Nonprofit Business Corporation and Co-operative Association Act. Upon such merger, the separate existence of Valley West Baptist Church shall cease, and Valley West Baptist Church and Sonrise Baptist Church shall become a single corporation.
- 2. Surviving Corporation. Sonrise Baptist Church shall be the surviving corporation and the corporate identity, existence, purposes, powers, franchises, rights and immunities of Sonrise Baptist Church shall continue unaffected by the merger.
- 3. Legal Effect of the Merger. The surviving corporation, Sonrise Baptist Church, shall upon the effective date of the merger and thereafter,
 - (a) Possess all of the rights, privileges, powers, immunities and franchises of a public and of a private nature, of each of Valley West Baptist Church and Sonrise Baptist Church, and all property (real, personal and mixed) and every other interest ever belonging to or due to each of Valley West Baptist Church and Sonrise Baptist Church; title to all real estate, or any interest therein, vested in Valley West Baptist Church (including the land and church building located at 3550 South 4400 West, West Valley City, Utah) shall not revert or be in any way impaired by reason of the merger; and
 - (b) Become and be subject to and responsible and liable for all of the debts, obligations, restrictions, disabilities, duties and liabilities of each of Valley West Baptist Church and Sonrise Baptist Church, and neither the rights of creditors nor any liens upon the property of either of Valley West Baptist Church or Sonrise Baptist Church will be impaired by the merger.

TERMS AND CONDITIONS OF THE PROPOSED MERGER

1. Constitution and Bylaws. The Constitution and By-Laws of Sonrise Baptist Church as existing and constituted immediately prior to the effective date of the merger shall be and constitute the Constitution and By-Laws of the surviving corporation, Sonrise Baptist Church.

2. Trustees and Officers. The duly qualified and acting Trustees of Valley West Baptist Church and Sonrise Baptist Church immediately prior to the effective date of the merger shall be the Trustees of the surviving corporation. Immediately after consummation of the merger, the following shall constitute the Trustees and Officers of the surviving corporation:

3. Registered Agent. The Registered Agent of the surviving corporation shall be:

- 4. Pastor. The Pastor of the surviving corporation shall be the Pastor of Sonrise Baptist Church.
- 5. Membership. All members in good standing of Valley West Baptist Church and all members in good standing of Sonrise Baptist Church shall be members of the surviving corporation, Sonrise Baptist Church.
- 6. Principal Office. The principal office and mailing address of the surviving corporation shall be at the present site of Valley West Baptist Church, 3550 S. 4400 W., West Vailey City, Utah.
- 7. Assets and Liabilities. All of the assets and liabilities of Valley West Baptist Church and of Sonrise Baptist Church (including the land and church building along with its contents, located at 3550 S. 4400 W. in West Valley City, Utah) shall be assumed by the surviving corporation, Sonrise Baptist Church.

9. Effective Date. The merger of Valley West Baptist Church into Sonrise Baptist Church will be effective upon the filing of articles of merger with and the issuance of a certificate of merger by the Division of Corporations and Commercial Code of the State of Utah, which shall be on or about March 1, 1994.

CHANGES IN THE ARTICLES OF INCORPORATION OF THE SURVIVING CORPORATION.

The following changes and additions to the Articles of Incorporation of Sonrise Baptist Church will be put into effect upon the merger:

1. Article IV is amended to read as follows:

The membership of this corporation shall consist of those persons who have confessed Jesus Christ as Lord and Savior, have publicly testified to their faith in the ordinance of Believer's Baptism by immersion following conversion, have expressed agreement with (and thereby agree to be governed by) the Constitution and By-Laws of this church, and who are seeking to live a life set apart unto Jesus Christ, and who have been duly received into membership by a majority of the church present at a regularly scheduled meeting of the church.

2. Article IX is amended to read as follows:

3. A new Article X is added following Article IX to read as follows:

To the fullest extent permitted by the Utah Nonprofit Corporation and Cooperative Association Act as now in effect or as it may hereafter be amended, a trustee or officer of this corporation shall be indemnified by this corporation against expenses actually and necessarily incurred by him in connection with the defense of any action, のでは、100mmの
