a perpetual easement, upon part of an entire tract of property, situate in the NE 1/4 NW 1/4 of Section 14, T. 4 N., R. 2 W., S.L.B. & M., in Davis County, Utah, for the purpose of constructing thereon an irrigation facility and appurtenant parts thereof, incident to the widening of an existing highway, State Route 108, known as Project No. 0108.
