POLE LINE EASEMENT

Fur Breeders Agricultural Cooperative a corporation doing business in the State of Utah, Grantor, hereby conveys and warrants to UTAH POWER & LIGHT COMPANY, a corporation, its successors in interest and assigns and licensees, Grantee, for the sum of One (\$1.00) Dollar and other valuable consideration, a perpetual easement and right of way for the erection and continued maintenance, repair, alteration, and replacement of the electric transmission, distribution, and telephone circuits of the Grantee, and one guy anchor and one pole poles, with the necessary guys, struts, crossarms and other attachments thereon, or affixed thereto, for the support of said circuits, to be erected and maintained on, under, upon and across the premises of the Grantor, in Cache County, Utah along a line described as follows:

Beginning in an existing distribution line on the Grantors' land at a point 525 feet south and 1765 feet west, more or less, from the east one quarter corner of Section 32, T. 12 N., R. 1 E., S.L.M., thence N. 3° 52' E. 207 feet to the north boundary fence of said land and being in the NW 1/4 of the SE 1/4 of said Section 32.

Together with all rights of ingress and egress necessary or convenient for the full and complete use, occupation and enjoyment of the easement hereby granted, and all rights and privileges incident thereto, including the right to cut and remove timber, trees, brush, overhanging branches and other obstructions which may injure or interfere with the Grantee's use, occupation or enjoyment of this easement.
