#### SPECIAL WARRANTY DEED

For a good and valuable consideration, receipt of which being hereby acknowledged, UNION AND JORDAN IRRIGATION COMPANY, a Utah corporation, grantor, hereby conveys and warrants, against all claiming by, through or under grantor and not otherwise, to SANDY CITY CORPORATION, a municipal corporation, grantee, the following described real property located in Salt Lake County, State of Utah:

### Storage Tank Site and Adjacent Land.

Commencing one rod east from the northwest corner, Lot 1, Section 5, Township 3 South, Range 1 East, Salt Lake Base and Meridian, and running thence south 40 rods; thence east 3 rods; thence north 28 rods; thence east 10 rods; thence north 12 rods; thence west 13 rods to beginning;
