(1) A Description of the Land Within the Project

Beginning at the Southwest Corner of the  
intersection of 400 West Street and 300 North  
Street; thence East along the South boundary line  
of 300 North Street to the Southeast Corner of the  
Intersection of 300 North Street and 200 West  
Street; thence North along the East boundary line  
of 200 West Street to a point where the North  
boundary line of 200 West Street intersects the  
North boundary line of Wall Street; thence  
Northwesterly along the North boundary line of Wall  
Street to the Northeast Corner of the Intersection  
of Wall Street and 800 North Street; thence West  
along the North boundary line of 800 North Street  
to the Northwest Corner of the intersection of 800  
North Street and 400 West Street; thence South  
along the West boundary line of 400 West Street to  
the point of Beginning.


The project area contains all of Blocks 114, 115,


