AN ORDINANCE AMENDING THE "UTAH COUNTY GENERAL PLAN, 1980" AND MORE PARTICULARLY AMENDING THE LAND USE PLAN OF SAID GENERAL PLAN TO INCLUDE AN ELECTRICAL TRANSMISSION CORRIDOR

Part I:

The Utah County Land Use Plan, a part of the "Utah County General Plan, 1980", is hereby amended to include a 40 foot electrical transmission line corridor for a 138 kv line in portions of section 24, T5S, R1W, and sections 19 & 20, T5S, R1E, unincorporated Utah County area, as shown on Exhibit "A" attached hereto and incorporated herein by this reference.

This ordinance shall take effect: 1. sixteen (16) days after it is passed, or 2. After it has been published, whichever date is later.


