The South Temple Historic District includes the area contained within the following boundaries:

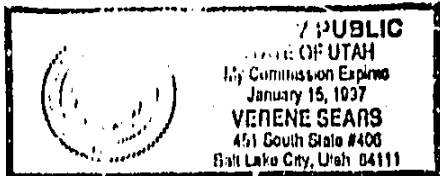
