AN ORDINANCE

AN ORDINANCE VACATING alley 125 feet east of Highland Drive and running north from Zenith Avenue, in Salt Lake City, Utah.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That alley 125 feet east of Highland Drive and running north from Zenith Avenue, in Salt Lake City, Utah, more particularly described as follows:

Beginning at the southeast corner of Lot 1, Blk. 1, Clermont Sub. of part of Sections 28 and 29, T 1 S., R. 1 E., S. E. L. & M., thence north 114.2 ft., thence N. 48 deg. 38' 35" W. 7.87 ft. to the south line of east-west alley, thence easterly 23.42 ft. along said south alley line, thence S. 47 deg. 49' 35" W. 7.75 ft. to the east line of north-south alley, thence south 114.0 ft. along said east alley line, thence west 12.0 ft. to the place of beginning;

and the same is hereby vacated and declared no longer to be public property for use as a street, avenue, alley or pedestrian way.

Said vacation is made expressly subject to all existing rights of way and easements of all public utilities of any and every description now located on, in, under or over the confines of the above described property and also subject to the right of entry thereon for the purpose of inspecting, maintaining, repairing, replacing, removing, altering or re-routing said utilities and all of them.

SECTION 2. In the opinion of the Board of Commissioners, it is necessary to the peace, health and safety of the inhabitants of Salt Lake City that this ordinance shall become effective immediately.

SECTION 3. This ordinance shall take effect upon its first publication. Passed by the Board of Commissioners of Salt Lake City, Utah, this 7th day of March, A. D. 1950.
