AN ORDINANCE

AN ORDINANCE VACATING ALLEYS between Crandall and Zenith Avenues, between Highland Drive and Chadwick Street in Salt Lake City, Utah.

Be it ordained by the Board of Commissioners of Salt Lake City, Utah:

SECTION 1. That alleys between Crandall and Zenith Avenues, between Highland Drive and Chadwick Streets in Salt Lake City, Utah, more particularly described as follows:

Beginning at the northeast corner of Lot 9, Block 1, Clermont Subdivision, of part of Sections 28 and 29, T. 1 S., R. 1 E., S. L. B. and M.; running thence South 131.2 ft., to the southeast corner of Lot 5, Block 1, said subdivision; thence East 555.48 ft.; thence South 45 deg. East 7.21 ft.; thence South 114 ft. to the southeast corner of Lot 41, Block 1, said subdivision; thence East 12 ft., to the southwest corner of Lot 40, Block 1, said subdivision; thence North 250.4 ft.; to the northwest corner of Lot 31, Block 1, said subdivision; thence West 12 ft., to the northeast corner of Lot 30, Block 1, said subdivision, thence South 114 ft.; thence South 45 deg. West 7.21 ft.; thence West 538 ft.; thence North 45 deg. West 7.55 ft.; thence North 114 ft.; to the northwest corner of Lot 10, Block 1 said subdivision; thence West 12 ft., to the point of beginning;

be and the same are hereby vacated and declared no longer to be public property for use as streets, avenues, alleys, or pedestrian ways.

Said vacation is made expressly subject to all existing rights of way and easements of all public utilities of any and every description now located on, in, under or over the confines of the above described property and also subject to the right of entry thereon for the purpose of inspecting, maintaining, repairing, replacing, removing, altering or rerouting said utilities and all of them.

SECTION 2. In the opinion of the Board of Commissioners, it is necessary to the peace, health and safety of the inhabitants of Salt Lake City that this ordinance shall become effective immediately.

SECTION 3. This ordinance shall take effect upon its first publication.
