RIGHT OF ENTRY AGREEMENT

The undersigned, SOUTH VALLEY WATER RECLAMATION FACILITY (Grantor), hereby grants to SALT LAKE COUNTY (County), permission to enter upon and take possession of the following described property:

Property located in Salt Lake County at 11601 South U-111 Highway (Sidwell No. 26-21-400-001), in a triangular shape as follows:

Beginning at the intersection of 11800 South and the extension of U-111, thence 900 feet eastward along 11800 South, thence northwesterly to a point on the extension of U-111 which is 400 feet northeasterly along the extension of U-111 from the intersection of U-111 and 11800 South, thence southwesterly 400 feet to the intersection of U-111 and 11800 South, and at all times remaining outside of the existing South Valley Water Reclamation Facility permiter road.

Grantor represents that title to the property is vested in Grantor and the Grantor has the authority to enter into this agreement. This right of entry is being conveyed by Grantor in order to allow County to begin construction of the realignment of 11800 South on the property, prior to completion of an agreement among Grantor, the County and South Jordan City concerning the transfer of the property by Grantor to South Jordan, vacation of a portion of 11800 South to South Valley, and construction of the public road. Prior to completion of the agreement transferring the property, the County may grade the property and lay base course for the road. The County shall relocate fencing on the property before any work takes place so that security is maintained.

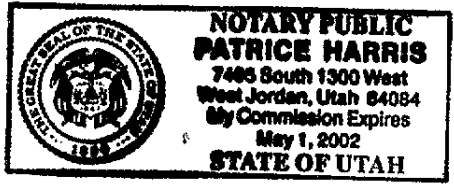
