CENTERLINE description for a 10 ft waterline easement at Antelope Square Shopping Center, Layton, Utah Beg at a point on the North R/W LINE of 2000 N. Street Layton, Utah. Said point being S89°47'W, 998.88 ft and N0°13'W, 50.00 ft from the S 1/4 Cor, Sec 7, T4N, R1W, SLB&M and running thence N36°47'W, 650.00 ft: thence N33°31'28"W, 268.12 ft.

Also including the following described centerline easement: Beginning at a point on the North R/W line of 2000 North Street Layton, Utah, said point being N0°03' 10"E, 50.00 ft. and S89°47'W 532.66 ft. from the S 1/4 Cor Sec 7, T4N, R1W, SLB&M, and running thence N0°03'10"E, 755.61 ft; thence S89°43'40"W, 993.00 ft; thence S53°13'W, 32.53 ft. to the Easterly R/W line of U.S. Highway 91.
