#### DEED OF TRUST (With Assignment of Rents) (SECURES FUTURE ADVANCES)

THIS DEED OF TRUST, made effective as of December 4, 2019, is between ZION RED ROCK RETREAT, LDC, a Utah limited liability company, whose mailing address is 11261 N. Turner, Esq., a member of the Utah State Bar Association, whose mailing address is 5295 So 320 W., Suite 150, Salt Lake City, Utah 84107, as "Trustee," and ELIZABETH MACKAY and BRANDOR MACKAY, as joint tenants, whose mailing address is 1696 Range Road, Saratoga Springs, Utah 84445, as "Beneficiary."

WITNESSETH: That Trustor CONVEYS AND WARRANDS TO TRUSTEE IN TRUST, WITH POWER OF SALE, the certain real property situated in <u>WASHINGTON</u> County, State of Utah, commonly known as <u>955 W</u>. <u>Grafton Road, ROCKVILLE, UT 84763</u>, and further described as follows (the "Property"):

FOCETHER WITH all buildings, fixtures and improvements thereon and all water rights, rights of way, easements, reats, issues, profits, income, tenements, hereditaments, privileges and appurtenances thereunto belonging, now or hereafter used or enjoyed with the Property, or any part thereof, SUBJECT, HOWEVER, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues, and profits.

FOR THE PURPOSE OF SECURING a payment of the indebtedness evidenced by (a) Secured Promissory Note of even date herewith in the principal amount of \$2,000,000.00 (referred to hereinafter as the "Promissory Note") made by Trustor, payable to the order of Beneficiary at the time, in the manner and with interest as therein set forth, and any extensions, renewals, amendments or modifications thereof, together with interest thereon as therein provided (except as limited herein) and (b) the performance of Trustor's covenants and agreements under this Deed of Trust and the Promissory Note, all of even date herewith, and any and all other documents now or hereafter required by Beneficiary and executed by Trustor or any other person or party in connection with the loan evidenced by the Promissory Note (all such documents are sometimes referred to herein collectively as the "Loan Documents").

AND, Trustor hereby warrants, covenants and agrees that Trustor is the lawful owner of the Property, with good and marketable title, free and clear of all encumbrances, liens or charges, excepting only those matters currently of record.

1. <u>Preservation of the Property</u>. To keep the Property in good condition and repair, not to remove or demolish any building thereon, to complete or restore promptly and in good and workmanlike manner any building which may be constructed, damaged or destroyed thereon; to comply with all laws, covenants and restrictions affecting the Property; not to commit or permit waste thereof; not to commit, suffer or permit any act upon the Property in violation of law; to do all other acts which from the character or use of the Property may be reaconably necessary to preserve the Property in good condition and repair. Defense of Actions Affecting the Property. 
