- 4. The Agency hereby issues this Certificate of Completion with respect to the Property pursuant to Section 3.21 of the Development Agreement. This Certificate of Completion shall be a preliminary determination of satisfactory completion of Renaissance's obligations required by the Development Agreement with respect to the Property. Notwithstanding the issuance of this Certificate of Completion, the duty of Renaissance to construct the Developer Improvements (as defined in the Development Agreement) in accordance with the Final Construction Documents (as defined in the Development Agreement) and Contract Documents (as defined in the Development Agreement) shall survive the issuance of this Certificate of Completion and causes of action related to Developer Improvements shall be limited solely by the applicable statute of limitations.
