**AMENDMENT TO THE AMENDED AND RESTATED MASTER DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR PILGRIMS LANDING and AMENDMENT TO THE BYLAWS OF PILGRIMS LANDING MASTER ASSOCIATION**

**This Amendment to the Amended and Restated Master Declaration of Covenants, Conditions, and Restrictions for Pilgrims Landing (the “Declaration”) and to the Bylaws of Pilgrims Landing Master Association (the “Bylaws”) is executed on the date set forth below by Pilgrims Landing Homeowners Association, Inc. (the “Association”).**

RECITALS

- A. Real property located in Utah County, State of Utah, known as the Pilgrims Landing, was subjected to covenants, conditions, and restrictions pursuant to a Declaration (as identified above) which was recorded July 30, 1998, as Entry No. 75697:1998, in the Utah County Recorder’s Office;
- B. On September 4, 1998, the First Amendment to Master Declaration of Covenants, Conditions and Restrictions of Pilgrims Landing was recorded as to Pilgrims Landing as Entry No. 90187:1998, in the Utah County Recorder’s Office;
- C. On June 2, 2014, the Declaration was recorded as to the Pilgrims Landing Subdivision as Entry No. 36850:2014 (the “Declaration”), in the Utah County Recorder’s Office;
- D. The Bylaws were recorded contemporaneously with the Declaration as Exhibit B to the Declaration;
- E. This Amendment to the Declaration (hereinafter, the “Amendment”) shall be binding against all members of the Association (as such term is defined in the Original Declaration and any amendments or supplements thereto) and the property described in EXHIBIT “A” to this Amendment, as well as any property described in the Declaration and any annexation or supplement thereto;
- F. This Amendment is intended to remove all provisions of the Declaration except those provisions expressly described herein;
- G. The President and Secretary hereby certify that this Amendment was approved by a vote of two-thirds (67%) of all Memberships as required by Section 11.1.1 of the Declaration and as permitted by Utah Code § 16-6a-709;
- H. The President and Secretary further certify that the portions of this Amendment amending the Bylaws were approved by at least a majority vote of a quorum of the Members of the Association, as required by Section 7.1 of the Bylaws;

NOW, THEREFORE, the Association, by and through its Board, hereby amends the Declaration as follows:

Declaration, shall be amended in its entirety to read as follows:

**1 DEFINITIONS**

Capitalized terms used in the Governing Documents (including recitals) have the following meanings:

**1.1 Lot** - Lot means a separately numbered parcel of property as shown on the Master Plan. Lots include Lots numbered 1, 3, 4, 5, 6, and 7 on the Master Plan and a 7.8 acre parcel of land identified as Utah County parcel nos. 58:002:0173 and 49:695:0001 as they existed on June 2, 2014 or as they have been subdivided after that date or as they may be subdivided from time to time from this date forth (identified herein as "Lot 2"). Lot 2 is a portion of Lot 8 shown on the Master Plan and should not be confused with Lot 2 shown on the Master Plan.

**1.2 Master Plan** - Master Plan means the Pilgrims Landing Preliminary Plat, approved by Lehi City and attached hereto as Exhibit "B", on file with the Utah County Recorder and any amendments or supplements thereto or any plat maps recorded for additional phases.

**1.3 Owner** - Owner means the record owner, whether one or more persons or entities, of the fee simple title to a Lot.

**2 EASEMENTS**

**2.1 Easements Reserved** Each Owner, their members, guests, customers, and invitees shall have a non-exclusive right and easement for the use, benefit and enjoyment in and to the areas shown as "common area" on the Master Plan, and such nonexclusive right and easement shall be appurtenant to and shall pass with the title to every Lot.

All other provisions of the Declaration not expressly written above are hereby deleted.

The Bylaws shall be amended in its entirety to read as follows:

All provisions of the Bylaws are hereby deleted.

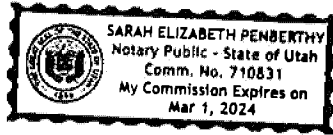

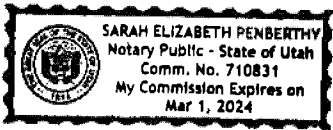
