Overlook at Union Park, LC (50% Interest), a Limited Liability Company of the State of Utah, Grantor, hereby GRANTS AND CONVEYS to the SANDY CITY CORPORATION, at 10,000 South Centennial Parkway, Sandy, Utah 84070, Grantee, for the sum of ten and other Dollars,

An undivided 50% interest in A Perpetual Easement, upon part of an entire tract of property situate in Lot 5, Overlook at Union Point, a subdivision in the SE1/4SE1/4 of Section 29, Township 2 South, Range 1 East, S.L.B. & M. for the purpose of constructing thereon cut and/or fill slopes, and appurtenant parts thereof incident to the reconstruction of 1300 East Street known as Project No. STP 2044(1)9.

Said part of an entire tract of land is described as follows:

Beginning at the southwesterly corner of said entire tract, along the existing right of way of 1300 East Street, at a point 15.798 meters perpendicularly distant easterly from the centerline of said project, at Engineer Station 5+611.54, said point of beginning lies 405.540 meters (1330.51 ft.) North 00° 05' 23" East along the East line of said Section 29, and 277.741 meters (911.22 ft.) North 89° 54' 37" West from the Southeast Corner of said Section 29, (a found brass cap); thence North 50° 00' 00" West 9.408 meters (30.87 ft.), along the proposed right of way line of 1300 East Street, to a point 15.516 meters perpendicularly distant easterly from the centerline of said project, at Engineer Station 5+620.90; thence South 79° 33' 52" East 17.685 meters (58.02 ft.); thence South 45° 06' 56" East 3.987 meters (13.08 ft.); thence South 89° 52' 00" West 13.011 meters (42.69 ft.) to the point of beginning.

The above described part of an entire tract of land contains 59.39 square meters.

Note: Rotate above project highway bearings 00° 00' 29" counter clockwise to equal Salt Lake County Surveyor Areas Reference Plat bearings.

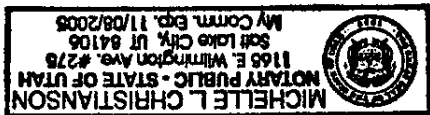
