Beginning at a point which is South 89°34'06" East 1078.32 feet along the North line of Section 25, from the North quarter corner of Section 25, Township 5 South, Range 1 East, Salt Lake Base and Meridian; thence North 0°30'36" East 51.42 feet to the existing fence; thence South 89°46'15" East 190.24 feet; thence North 8.81 feet; thence South 89°27'34" East 70.84 feet; thence South 0°31'36" West 169 feet; thence North 89°46'15" West 261.0 feet; thence North 0°30'36" East 108.77 feet to the place of beginning.

TOGETHER with and subject to the following right-of-way: Commencing 39.53 chains South and 6.35 chains West of the Northeast corner of the Southeast Quarter of Section 24, Township 5 South, Range 1 East, Salt Lake Base and Meridian; thence West 15 chains; thence North 12 feet; thence East 15 chains; thence South 12 feet to the place of beginning.

SUBJECT and RESERVING to the Grantor herein, the existing 14 foot Right-of-Way over and across the herein described property. Said easement to terminate at the time the adjoining property of the Grantor on the West abuts a dedicated road, in this immediate vicinity, serving this immediate vicinity.
