PERPETUAL EASEMENT * * * * * * * * *

KNOW ALL MEN BY THESE PRESENTS:

THAT WE, VERN W. THOMPSON and wife, WANDA L. THOMPSON, and HAROLD L. TRIBE, and wife, DELIA S. TRIBE, being the owners of the following described property, for and in consideration of the sum of one dollars (\$1.00) and other good and valuable consideration, paid by the Roy City, a municipal corporation, of and for the County of Weber, State of Utah, the receipt of which is hereby acknowledged, do hereby give, grant and quit claim unto Roy City, County of Weber, State of Utah, an easement or right of way for the construction, improvement, operation and maintenance of culinary water line thirty feet (30) in width during the period of initial construction of said water line and a perpetual feet (10) in width after initial construction of said water line, with a center line of said easement lying and being situated in Weber County, State of Utah, to-wit:

> A part of the Southeast 1/4 of the Southwest 1/4 of Siction 2, Township 5 North, Range 2 West, Salt Lake Base and Meridian, Beginning at a point on the North line of 4000 South Street 5 .0 feet West of the Southwest corner of Hal-Vern Subdivision as platted in the map records of Weber County, Utah; thence North parallel to Hal-Vern Subdivision to a point on the Southeast line of the Union Pacific Railroad Right-of-way; thence North 56° 30' West to a projected point on the Northwest Right-of-way of the Denver Rio Grande Railroad Rightof-way, said point being the Southeast corner of Lot 95 of Ken-Mar Subdivision.

To have and to hold the said easement or right of way unto the said Roy City, a Municipal Corporation, in and for Weber County, State of Utah, so long as the same shall be used and maintained as a right of way for a culinary water line; and the grantors hereby dedicate their respective interests in said strip of land to public use for said purposes.
