TRUSTEE'S DEED

This Trustee's Deed is made by Kenneth J. Sheppard, as trustee under the trust deed described below, to ANB Venture, LLC, a Delaware limited liability company, as grantee hereunder.

By Deed of Trust filed for record December 14, 2007, as Document No. 20070058971 in the official records of Washington County, Utah (the "Deed of Trust"), Elin Valley Planning and Development, LLC, and Mellon Valley, LLC, as co-trustors (the "Co-Trustors"), did convey to Southern Utah Title Company as trustee, for the benefit of ANB Financial, N.A., as beneficiary, upon the trust therein expressed, the property hereinafter described to secure the payment of a certain note (the "Note") and other obligations as more particularly set forth in the Deed of Trust.

The Deed of Trust was assigned to ANB Venture, LLC by Assignment of Deed of Trust filed for record on April 7, 2009 as Document no. 20090013026 in the official records of Washington County, Utah.

A default occurred under the terms of the Note and the Deed of Trust. A Notice of Default and Election to Sell was executed and filed for record on August 5, 2009 as Document No. 20090030548 in the official records of Washington County, Utah (the "Notice of Default").

Not later than 10 days after the Notice of Default was recorded, a copy of the Notice of Default with the recording date shown thereon was mailed, by certified mail, with postage prepaid, a copy of such Notice of Default with the recording date shown thereon, to the Co-Trustors and to each person whose name and address were set forth in a request for notice filed in the official records of Washington County, Utah prior to the filing of the Notice of Default.

The default was not cured within the three months following the filing for record of the Notice of Default.

Kenneth J. Sheppard was appointed as successor trustee under the Deed of Trust by a Substitution of Trustee executed by filed for record September 16, 2010, as Document No. 20100031172, in the official records of Washington County, Utah.

Trustee executed a Notice of Trustee's Sale (the "Notice of Trustee's Sale"), stating that the property described in the Deed of Trust would be sold to the highest bidder at public auction to be held at the Washington County Fifth Judicial District Court courthouse, 206 West Tabernacle, St. George, Utah, on October 14, 2010 at 11:00 a.m., and caused the Notice of Sale to be:

- (a) published in the Spectrum, a newspaper of general circulation in Washington County, Utah, three times, once a week for three consecutive weeks (specifically on September 12, September 24 and October 1, 2010), the last publication being at least 10 days and not more than 30 days prior to the date of sale, and

(b) posted at least 20 days prior to the date of sale in a conspicuous place on the property to be sold and at the office of the Washington County Recorder, and

(c) mailed, by certified mail, with postage prepaid, at least 20 days prior to the date of sale, to the Co-Trustors, at the address set forth in the said Deed of Trust, and to each person whose name and address were set forth in a request for notice filed for public record prior to the filing of the Notice of Default.

At the time and place specified in the Notice of Sale, the Trustee sold the property described in Exhibit A hereto at public auction to the Grantee, the highest bidder, for \$13,559,088.

All applicable statutory provisions of the State of Utah and all of the provisions of the Deed of Trust were complied with as to the acts to be performed and the notices to be given.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Kenneth J. Sheppard, by virtue of his authority as trustee under the Deed of Trust, grants and conveys to Grantee, without covenant or warranty of any kind, express or implied, including but not limited to any warranty as to title, liens, possession, taxes, encumbrances or condition of the property, effective as of the time of sale, all of the following described real property located in Washington County, Utah:

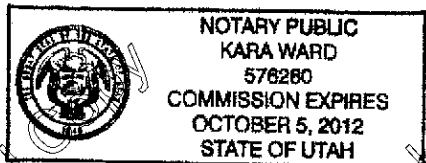
