NOTICE OF REINVESTMENT FEE COVENANT

(Quailhill Plat D)

Pursuant to Utah Code Ann. § 57-1-46(6), the Mt. Saratoga Master Association, Inc., a Utah non-profit corporation (the "Association"), hereby gives notice of a Reinvestment Fee Covenant which burdens the real property described in Exhibit A (the "Burdened Property"), attached hereto, and any additional land that is annexed into and made subject to the Master Declaration of Covenants, Conditions, and Restrictions and Reservation of Easements for Mt.
