EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that LARRY D. JENKINS and SHEROLYN

R. JENKINS, husband and wife of MORGAN County, Utah
 (whether one or more than one), hereinafter called the Grantor, in consideration of the sum
 of Ten and No/100 Dollars (\$10.00), to him paid by MORGAN CITY CORPORATION
 of MORGAN County, Utah, a corporation, hereinafter called the Grantee, the
 receipt of which is hereby acknowledged, does hereby grant to the said Grantee, his (their,
 its) heirs, executors, administrators, successors and assigns a perpetual easement and
 right-of-way 10 feet in width, being 0 feet left and 10 feet right, and a temporary
 construction easement 60 feet in width, being 30 feet left and 30 feet right of the
 described alignment for the construction, operation, maintenance, removal and replacement
 of a pipeline or pipelines and their appurtenant works upon, over, under and across the
 following described lands owned by the Grantor(s) lying in MORGAN County, Utah:
 Part of N 1/2 SE 1/4 & part S 1/2 NE 1/4 Sec 36, T4N, R2E, SLB&M, U.S. Survey;
 BEG at pt which bears N 1881.0 ft & N 85°52' W 220.0 ft fr SE Cor of sd Sec 36, & run th
 N 86°13' W 1168.0 ft alg N side of Spring St; N 02°12' E 210.0 ft; N86°13' W 175.0 ft;
 N 02° 12' E 565.0 ft; S 82°25' W 524.0 ft to Extension of Young St; th along sd St.
 N 66°35' E 1470.0 ft into Weber River; th up sd river S 49° E 500.0 ft; th leav. sd
 river S 307.0 ft to 1/4 Sec line; S 01° W 491.41 ft; S 13°50' E 93.0 ft; S 62°35' E 101.0
 ft; th S 115.0 ft to Spring St. to pt of beg.

The alignment of said easement is described as follows:
 A part of Section 36, T4N, R2E, SLB&M, beg. at a point located N 00°44'30" West
 along the section line 1807.32 feet and N 86°05'00" W 1219.22 ft. from the SE cor. of sd
 Sec 36, sd pt of beg also located N 03°55'00" E 33.0 ft. from the pt of centerline inter-
 section of 100 South (Spring Street) and Imperial Dr. (Basis of Bearing being the center-
 line of 100 South which bear N 86°05'00" W); and run. th along the arc of a 1003.67 ft.
 radius curve to the right a distance of 297.80 ft, radius pt bears to S 86°05'00" E;
 th along the arc of an 850.69 ft radius curve to the left a distance of 296.95 ft, radius
 point bears to N 69°05'00" West; th N 00°55'00" E 50.0 ft to the point of tangency with a
 778.65 ft radius curve to the left; th along sd curve a distance of 344.28 ft, radius pt
 bears to N 89°05'00" West; th N 24°25'00" W 126.32 ft to grantor's North property line,
 said North Property Line also being the South right-of-way line of Young Street.

Together with the right of ingress and egress for the purposes for which the above mentioned rights are herein granted.

PROVIDED, HOWEVER, that the exercise by the Grantee of the rights hereby granted shall
 be subject to, and in accord with, the following conditions:
 Water hook up for new home now under construction, at 784 East Young St.
