Current Provisions (pg. 6) - Article II Restriction on all Lots

...
"No Resubdivision." No lot may be resubdivided without the consent of the Architecture Committee and no resubdivision of any lot may result in the construction of any additional dwelling units within the subdivision.

Amended Provision (pg. 6) - Article II Restriction on all Lots

INSERT:

Resubdivision. No lot may be resubdivided without the express written consent of the Architecture Committee which shall not be unreasonably withheld. No resubdivision of any lot may result in a lot which does not conform with the Draper General Master Plan and current zoning ordinances.

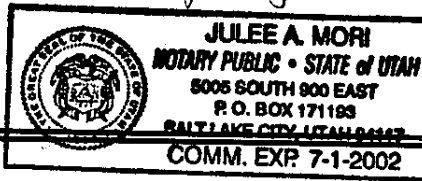
