of Salt Lake County, State of Utah, Grantors, do hereby convey and warrant to the Salt Lake City Suburban Sanitary District, Salt Lake County, Utah, organized and existing under and by virtue of the laws of the State of Utah, Grantee, for the sum of One dollar & other consideration. ( District to pay entire cost of line installation. ) DOLLARS (\$ 1.00 ) receipt of which is hereby acknowledged, a right of way and easement for the purpose of digging a trench along said right of way, and to lay, maintain, operate, repair, remove or replace the pipe line for transportation through and across the Grantors land and premises in Salt Lake County, State of Utah, and located in: Com 1420 ft S & 336 ft W fr the N E Cor of Section 35, T1S, R1E, S L Base & Mer. N 70°15' W 234 ft; N 407 ft to Mill Creek, S 77°06' E 128 ft; S 30°01' E 99.6 ft; S 60°26' E 56.5 ft; S 344 ft to beg. 2 Ac.

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows:  
Enters the West boundry line of the above described property at a point 190 ft M or L North fr the S W property corner, and running thence S 83°20' E 123 ft; thence S 66°33' E 107 ft M or L to the east property line.

TO HAVE AND TO HOLD the same unto the Salt Lake City Suburban Sanitary District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right of way, and to maintain, operate, repair, remove or replace the same. The said Grantor... to fully use the said premises except for the purposes for which this right of way or easement is granted to the said Grantee.
