Barrie G. McKay, Trustee, Grantor,  
of Bountiful, County of Davis, State of Utah,  
hereby GRANT AND CONVEY to the UTAH DEPARTMENT OF TRANSPORTATION, at  
4501 South 2700 West, Salt Lake City, Utah 84119, Grantee, for the sum  
of Three Hundred and fourteen (\$314.00) Dollars,

a perpetual easement, upon part of an entire tract of property, situate in Lot 3,  
Block 3, Plat B, Huntsville Survey, a subdivision in the E 1/4 of Section 18, T. 6 N.,  
R. 2 E., S.L.B. & M., in Weber County, Utah, for the purpose of constructing and  
maintaining thereon an irrigation facility and appurtenant parts thereof, incident  
to the spot improvements of an existing highway, State Route 39, known as Project  
No. 0039.

Said part of an entire tract is a strip of land 10.00 feet wide, adjoining westerly  
the following described portion of the existing westerly right-of-way line of 7800  
East Street:

Beginning at the intersection of said existing westerly right-of-way line and the  
existing northerly right-of-way line of 100 South Street, which point is 43.12 feet  
radially distant westerly from the center line of said project at Engineer Station  
15+74.16, said point being approximately 35 feet West along the south line of said  
Lot 3 and 16.5 feet N. 01°34'51" W. from the southeast corner of said Lot 3, and  
running thence N. 01°34'51" W. 45.94 feet along said existing westerly right-of-way  
line.

The above described strip of land contains 456 square feet or 0.01 acre in area,  
more or less.

The boundary lines of said strip of land shall be prolonged and/or shortened to  
begin and end on, and conform to the southerly boundary line of said entire tract.

After said irrigation facility and appurtenant parts thereof are constructed on the  
above described part of an entire tract at the expense of the Utah Department of  
Transportation, said Utah Department of Transportation is thereafter relieved of any  
further claim or demand for costs, damages or maintenance charges which may accrue  
against said irrigation facility and appurtenant parts thereof.

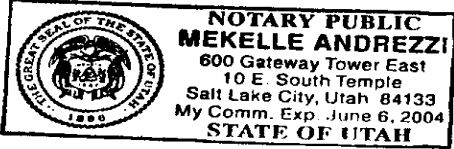
