THE STATE OF UTAIN, through and by its State Land Board, by its duly appointed qualified Director, grantor, hereby quitclaims to E. R. McKAY of Huntsville, Utah, grantee, for the consideration recited in that certain Deed dated May 12, 1952, which this instrument reforms, all its right, title and interest in and to the following described tract of land in Weber County, State of Utah, to-wit:

Commencing at the Northeast corner of the Southeast Quarter (SE_4^1) of the Northwest Quarter (NW_4^1) of Section Seven (7), Township Six (6) North, Range Two (2) East, Salt Lake Meridian; thence running South along the quarter section line 3.45 chains; thence South 71° West 6.30° chains; thence South 8°50' East 6.02 chains; thence South 48°11' East 6.846 chains to the East line of the Northwest Quarter (NW_4^1) of said Section 7; thence South 3.97 chains more or less to the center of said Section 7, thence East a distance of 8.76 chains; thence North 0°40' East 29.74 chains; thence 50uth 88°51' West 1.07 chains; thence South 0°40' East 9.17 chains; thence South 88°51' West 8 chains more or less to the place of beginning, Containing 23.57 acres more or less.

Also commencing on the South line of Section Seven (7), Township Six (6) North, Range Two (2) East, Salt Lake Meridian, at a point 17.45 chains North 88°51' East from the Southwest Quarter (SE_{4}^{1}) of the Southeast Quarter (SE_{4}^{1}) of said Section 7; running thence North 88°51' East 10.50 chains along the South line of said Section to the center of Street; thence North 1°40' West along the center of said Street 10.67 chains; thence North 86°53' West 10.53 chains; thence South 1°54' East 11.43 chains more or less to the place of beginning, subject to a public highway over the East portion thereof. Excepting and reserving from the above described tract or tracts of land all existing easements and rights-of-way of whatsoever kind or nature.

Excepting and reserving to the State of Utah all coal, oil, gas, mines, metals, gravel and all other minerals of whatsoever kind or nature in the above land, and to it, or persons authorized by it, the right to prospect for, mine and remove the same, together with the right to occupy and use so much of the surface of said lands as may be required for all purposes reasonably incident to the mining and removal of said minerals.
