## FIRST SUPPLEMENT TO THE DECLARATION OF PROTECTIVE COVENANTS FOR BLOOMFIELD FARMS SUBDIVISION PHASE 4 (a planned residential development)

This FIRST SUPPLEMENT TO THE DECLARATION OF PROTECTIVE COVENANTS FOR BLOOMFIELD FARMS SUBDIVISION PHASE 4, is made and executed by IVORY DEVELOPMENT, LLC, a Utah limited partnership, of 970 E. Woodoak Lane, Salt Lake City, Utah 84117 (hereinafter referred to as "Declarant").

## **RECITALS**

Whereas, the Amended and Restated Declaration of Covenants, Conditions and Restrictions for Bloomfield Farms Planned Unit Development was recorded in the office of the County Recorder of Salt Lake County, Utah on June 17, 2004 as Entry No. 9092903 in Book 9002 at Pages 211-238 of the Official Records (the "Declaration").

Whereas, the related Plat Maps for Phases 1, 2 and 3 of the Project have also been recorded in the office of the County Recorder of Salt Lake County, Utah.

Whereas, under Section 4 of the Declaration, Declarant reserved an option to expand the Planned Unit Development in accordance with the Declaration.

Whereas, Declarant is the fee simple owner of record of that certain real property located in Salt Lake County, Utah and described with particularity on Exhibit "A-4" attached hereto and incorporated herein by this reference (the "Phase 4 Property").

Whereas, under the provisions of the Declaration, Declarant expressly reserved the unilateral right to expand the application of the Declaration to other real property.

Whereas, Declarant desires to expand the planned unit development by creating on the PHASE 4 Property additional Lots.

Whereas, Declarant now intends that the Phase 4 Property shall become subject to the Declaration.

- NOW, THEREFORE, for the reasons recited above, and for the benefit of the planned unit development and the Lot Owners thereof, Declarant hereby executes this First Supplement to the Amended and Restated Declaration of Covenants, Conditions and Restrictions for Bloomfield Farms Phase 4.
- 1. **Supplement to Definitions**. Article I of the Declaration, entitled "Definitions," is hereby modified to include the following supplemental definitions:
- A. First Supplemental Declaration shall mean and refer to this First Supplement to the Amended and Restated Declaration of Covenants, Conditions and Restrictions for Bloomfield Farms Phase 4.
- B. **PHASE 4 Map** shall mean and refer to the Plat Map of Phase 4 of the Project, prepared and certified to by Ralph Goff, a duly registered Utah Land Surveyor holding Certificate No. 144147, and filed for record in the Office of the County Recorder of Salt Lake County, Utah concurrently with the filing of this First Supplemental Declaration.
- C. **Planned Unit Development** shall mean and refer to Bloomfield Farms Subdivision Phases 1, 2, 3 and 4.

Except as otherwise herein provided, the definition of terms contained in the Declaration are incorporated herein by this reference.

- 2. **Legal Description**. The real property described in Exhibit A-4 is hereby submitted to the provisions of the Declaration and said land shall be held, transferred, sold, conveyed and occupied subject to the provisions of the Declaration as it may be supplemented or amended from time to time.
- 3. Annexation. Declarant hereby declares that the Phase 4 Property shall be annexed to and become subject to the Declaration, which, upon recordation of this First Supplemental Declaration, shall constitute and effectuate the expansion of the Project, making the real property described in Exhibit A-4 subject to this Declaration and the functions, powers, rights, duties and jurisdiction of the Association and Architectural Review Committee.
- 4. Total Number of Units Revised. As shown on the Phase 4 Map, fifty-two (52) new Lots, Numbers 401-452, are or will be constructed and/or created in the Project on the Phase 4 Property. Upon the recordation of the Phase 4 Map and this First Supplemental Declaration, the total number of Lots in the Project will be one hundred eighty-three (183). The additional Lots (and the homes to be constructed therein) are or will be substantially similar in construction, design and quality to the Lots and homes in the prior Phases.
- 5. Effective Date. The effective date of this First Supplemental Declaration and the Phase 4 Map shall be the date on which said instruments are filed for record in the Office of the County Recorder of Salt Lake County, Utah.
