EASEMENT AND RIGHT OF WAY

PROGRESSIVE DEVELOPMENT COMPANY, A Utah Corporation, hereby grants and conveys to SALT LAKE CITY, a municipal corporation of the State of Utah, Grantee, the following described easement executed by Salt Lake City Corporation July 13, 1966:

Beginning at a point in the Southerly and Westerly line of Gordon Lane which point is S 89°54'12" West 51.05 feet, South 49°42' West 368.46 feet more or less and North 42°06' West along the Southerly and Westerly line of Gordon Lane 27.01 feet from the Southwest corner of Lot 5, Block 7, Ten Acre Plat "A", Big Field Survey, in Section 6, Township 2 South, Range 1 East, Salt Lake Base and Meridian, said point being 1500.32 feet more or less North and 1897.63 feet West more or less from the Southeast corner of Lot 1, Said Block 7 and running thence South 49°42' West 86.68 feet; thence North 10°00' East 15.65 feet along creek; thence North 49°42' East 74.32 feet to the Southwesterly line of Gordon Lane; thence South 42°06' East 10.00 feet along said line to the point of beginning.
