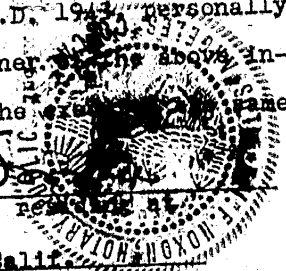

WARRANTY DEED. 638-30-26

ELIZARETH GORDON, a widow; MARY GORDON, a single woman; JAMES P. GORDON and LOUISE L. GORDON, his wife; of Salt Lake City, Salt Lake County, State of Utah, GRANTORS, hereby convey and warrant to SALT LAKE CITY, a municipal corporation of the State of Utah, GRANTEE, for the sum of Ten and 00/100 (\$10.00) Dollars and other good and valuable consideration, receipt of which is hereby acknowledged the following described property situated in Salt Lake County, State of Utah, to-wit:

Beginning at a point on a fence line which bears N. 4° 00' East more or less, said fence being the boundary line of property belonging to Mrs. Elizabeth Gordon and Mrs. Helen H. Musser; said point being N. 89° 54' 12" E. 310.00 ft. from the SW corner of Lot 5, Block 7, 10 Acre Plat "A", Big Field Survey, the same being a part of Section 6, T. 2 S, R. 1 E., S.L.B. & M. 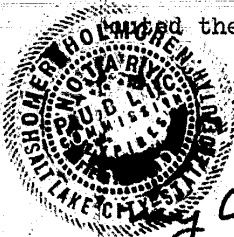
