It is further provided that any amendment to said prior declaration will apply to amend this Declaration unless such amendment specifically excepts all or part of the property described herein.

This Declaration shall take affect upon recordation in the office of the Salt Lake County Recorder.



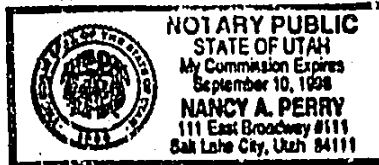

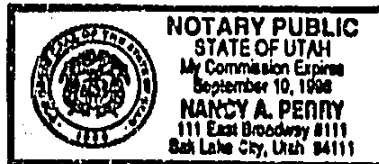
