SPECIAL WARRANTY DEED

CORPORATION OF THE PRESIDING BISHOP OF THE CHURCH OF JESUS CHRIST OF LATTER-DAY SAINTS, a Utah corporation sole, Grantor, of Salt Lake City, County of Salt Lake, State of Utah, hereby CONVEYS and WARRANTS, only against acts of itself and none other or against all claiming by, through or under it to DARRYL PACK and JOYCE S. PACK, as joint tenants with full rights of survivorship and not as tenants in common, Grantees, of 790 NORTH 500 WEST, BOUNTIFUL, Utah, for the sum of TEN DOLLARS (\$10.00) and other good and valuable consideration, the following tract of land situate in the County of Davis, State of Utah, and more particularly described as follows:

See Exhibit "A" attached hereto and by this reference made a part hereof.

Subject to easements, rights, rights-of-way, reservations, conditions, restrictions, covenants and all taxes and assessments of record or enforceable in law or equity.

The Grantor specifically reserves and excepts unto itself all minerals, coal, carbons, hydrocarbons, oil, gas, chemical elements and compounds whether in solid, liquid or gaseous form, and all steam and other forms of thermal energy on, in or under the above-described land.

In reserving the mineral and energy rights, the Grantor hereby waives all surface entry rights including, but not limited to, energy and mineral exploration or extraction on the above-described property. In addition, the Grantor will indemnify and reimburse the Grantees for any subsidence or other damages caused by sub-surface activities of the Grantor, its successor or assigns.
