MEMORANDUM OF OPTION AND DEVELOPMENT AGREEMENT

This MEMORANDUM OF OPTION AND DEVELOPMENT AGREEMENT (this "Memorandum") is entered into as of December 16, 2021, by and between Foothill Village 3 & 4 - Santaquin, L.P., a Delaware limited partnership ("Owner"), and D.R. Horton, Inc., a Delaware corporation ("Builder").

- 1. Option Agreement. Upon the terms and conditions as set forth in that certain written agreement titled "Option and Development Agreement" dated for reference December 16, 2021, by and between Owner and Builder (the "Option Agreement"), all of which terms and conditions are specifically made a part hereof as fully and completely as if specifically set out in full, Owner grants to Builder the option to purchase that certain real property in the County of Utah, State of Utah, as described in the attached Exhibit A (the "Option"). The term of the Option commenced upon the date hereof and shall expire on July 20, 2022 unless earlier terminated pursuant to the terms of the Option Agreement.

- 3. <u>No Alteration of Option Agreement</u>. This Memorandum is subject to the terms, covenants, conditions and provisions of the Option Agreement and is not intended and shall not be construed to alter, modify, limit, abridge or enlarge any of the terms, covenants, conditions or provisions of the Option Agreement.
- 4. <u>Termination</u>. This Memorandum shall automatically terminate and be of no further force or effect with respect to (A) any dwelling unit constructed on the Property for which a certificate of occupancy has been obtained, concurrently with the conveyance of such dwelling unit to a purchaser of such dwelling unit, and (B) any portion of the Property (or interest therein) that is conveyed to the City of Santaquin, any other governmental or quasi-governmental authority, a utility company, or any homeowner's association. Notwithstanding such automatic release, Owner agrees to provide any applicable release within five (5) days of request therefor by Builder.
