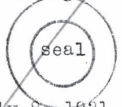

No. 31674.- RIGHT OF WAY.

Chas. H. Poll and Cora E. Poll, husband and wife of South Weber in County of Davis, State of Utah, the parties of the first part for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable considerations in hand paid by the Board of Education of the Davis County School District of the State of Utah, the party of the second part, the receipt whereof is hereby acknowledged, do by these presents grant and convey to the said Board of Education of the Davis County School District, its successors and assigns, a perpetual right of way to lay, construct, operate and maintain a pipe line system for irrigation, domestic, culinary and other purposes, with all the necessary appurtenances incident to said system on, over and across the following described tract of land in Davis County, State of Utah, to-wit:

Commencing at the Northeast corner of Section 33, Township 5 North, Range 1 West, Salt Lake Meridian, United States Survey, running thence South 20 chains thence West 6.66 chains; thence North 45°20' West 3.36 chains along the center of the Central canal; thence along the center of said canal North 67°48' West 6.00 chains; thence North 71°30' West still along said canal 5.68 chains; thence North 13.52 chains; thence East 20.00 chains to the point of commencement, containing 34.74 acres.

That said pipe line shall be placed and kept at all points buried not less than eighteen inches beneath the surface of the ground, and shall be so maintained and operated as not to interfere with the cultivation of said, or any portion of said land.

Said pipe line system, with its necessary appurtenances incident to the said system shall be constructed, maintained, operated and if re-constructed, shall be re-constructed and maintained perpetually at the place now designated by the said parties of the first part, under, over and across the tract of land hereinabove described.

AFFIDAVIT.

I, Agnes H. Tubbs Rutherford, being first duly sworn depose and say: That I reside in Ogden, Weber County, Utah; that I am the surviving wife of George Tubbs Jr., deceased; that George Tubbs Jr., my late husband, was the son of George Tubbs and Eliza Tubbs, both deceased, late of Farmington, Davis County, Utah; that my said husband, George Tubbs Jr., is the person named as grantee in that certain deed recorded on March 1, 1899, at page 297, Book Q, of the Records of Davis County, Utah; that shortly after the execution of said deed George Tubbs and Eliza Tubbs, mother of my said husband died and George Tubbs Jr., then and thereafter became known as George Tubbs, omitting Junior from his name; that George Tubbs Jr., my said husband is the grantee in that certain deed recorded November 20, 1899, on page 157, in Book P of Deeds of the records of the County Recorder of Davis County, Utah, and also is the grantee named in that certain deed recorded November 1, 1899, on page 157, of Book P of Deeds of the County Records of Davis County, Utah; that my said husband, formerly known as George Tubbs Jr., but afterwards known as George Tubbs, died on or about July 16, 1906, and that affiant filed her petition in the office of the County Clerk of Davis County, Utah, for the appointment of herself as administrator of said estate, and that the estate of my late husband was probated in the name of George Tubbs; that that certain decree of distribution in the District Court of Davis County Utah, in the matter of the estate of George Tubbs, deceased, and recorded January 10, 1906, in Book B of Decrees, at page 427, of the records of the County Recorder of Davis County, Utah, is the same person as George Tubbs Jr.; that the said George Tubbs Jr., after death of his said father and mother was never known by any other name than George Tubbs; that all of his transactions of every name or nature were, to affiants personal knowledge, transacted in the name of George Tubbs.
