RIGHT OF WAY EASEMENT

For value received, The Childrens Center ("Grantor"), hereby grants to PacifiCorp, an Oregon Corporation, d/b/a Rocky Mountain Power its successors and assigns, ("Grantee"), an easement for a right of way for the construction, reconstruction, operation, maintenance, repair, replacement, enlargement, and removal of electric power transmission, distribution and communication lines and all necessary or desirable accessories and appurtenances thereto, including without limitation: supporting towers, poles, props, guys and anchors, including guys and anchors outside of the right of way; wires, fibers, cables and other conductors and conduits therefor; and pads, transformers, switches, vaults and cabinets, along the general course now located by Grantee on, over, or under the surface of the real property of Grantor in Salt Lake County, State of Utah more particularly described as follows and as more particularly described and/or shown on Exhibit(s) A. attached hereto and by this reference made a part hereof:

BEGINNING AT A POINT N89°58'09"E 165.34 FEET AND SOUTH 412.70 FEET FROM THE NORTHWEST CORNER OF LOT 5, BLOCK 36, PLAT "B", SALT LAKE CITY SURVEY AND RUNNING N89°58'28"E 7.09 FEET; THENCE S30°53'31"E 39.99 FEET; THENCE S59°06'29"W 10.00 FEET; THENCE N30°53'31"W 37.06 FEET; THENCE N00°07'26"W 7.65 FEET TO THE POINT OF BEGINNING.

CONTAINS 412.40 SQ. FT.

BASIS OF BEARING IS N00°02'38"W 792.210' BETWEEN THE FOUND MONUMENTS ALONG 300 EAST STREET BETWEEN BROADWAY (300 SOUTH STREET) AND 400 SOUTH STREET.

Together with the right of access to the right of way from adjacent lands of Grantor for all activities in connection with the purposes for which this easement has been granted; and together with the present and (without payment therefor) the future right to keep the right of way

and adjacent lands clear of all brush, trees, timber, structures, buildings and other hazards which might endanger Grantee's facilities or impede Grantee's activities.

At no time shall Grantor place, use or permit any equipment or material of any kind that exceeds twelve (12) feet in height, light any fires, place or store any flammable materials (other than agricultural crops), on or within the boundaries of the right of way. Subject to the foregoing limitations, the surface of the right of way may be used for agricultural crops and other purposes not inconsistent, as determined by Grantee, with the purposes for which this easement has been granted.

The rights and obligations of the parties hereto shall be binding upon and shall benefit their respective heirs, successors and assigns.

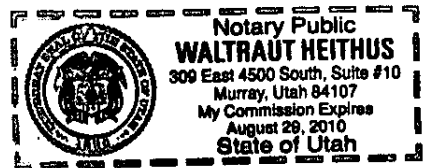

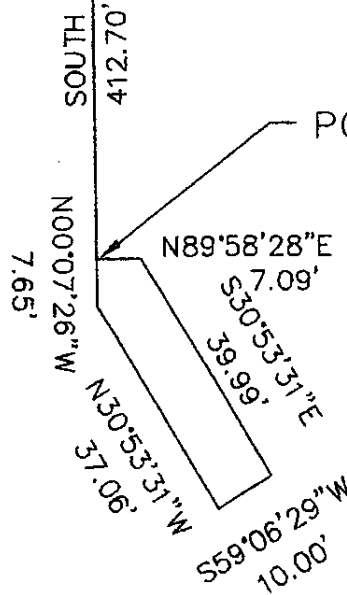


NORTHWEST CORNER
