his wife, Grantor s , do hereby convey and warrant to Pacificorp, an Oregon corporation, dba Utah Power & Light Company, whose principal place of business is located at 1407 West North Temple, Salt Lake City, Utah, its successors in interest and assigns, Grantee, for the sum of fen (\$10.00) Dollars and other valuable consideration, a perpetual easement and right of way for the erection, operation, maintenance, repair, alteration, enlargement, inspection, relocation and replacement of electric transmission and distribution lines, communications circuits, fiber optic cables and associated facilities, and no poles and no guy anchors, with the necessary guys, stubs, crossarms, braces and other attachments affixed thereto, for the support of said lines and circuits, on, over, under and across real property located in Salt Lake County, Utah, described as follows:

A right of way 40 feet in width, being 20 feet on each side of the following described survey line:



Beginning at a pole in an existing power line on the Grantor's land at a point 868 feet south and 1790 feet east, more or less, from the west one quarter corner of Section 20, T. 2S., R. 1E., S.L.M., thence N.0'45'E. 175 feet, more or less, to the north boundary line of said land and being in the NE4 of the SW4 of said Section 20; containing 0.16 of an acre, more or less.
