N 0°12' W 100 ft; N 89°48' E 470.71 ft; So 2°46' W 54.65 ft; S 87°28' 30" W 197.3 ft; S 68°08'30" W 104.2 ft N 89°51'30" W 173.9 ft; to beg 0.92 ac.

the center line of said pipe shall extend through and across the above land and premises on a line described approximately as follows:  
Crossing from East line to a pt on the South line

TO HAVE AND TO HOLD the same unto the Taylorsville-Bennion Sewer District so long as such pipe line shall be maintained, with the right of ingress and egress to and from said right-of-way, and to maintain, operate, repair, remove or replace the same. The said Grantor to fully use the said premises except for the purposes for which this right-of-way or easement is granted to the said Grantee.

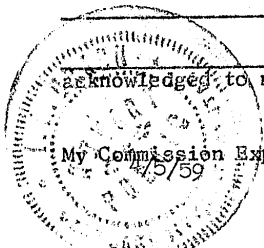
