NOW, THEREFORE, the Declarant hereby amends **Article IV** of the Declaration to the following new Section 4.5 (all existing language to remain the same):

4.5 Solar Energy Systems. No solar energy system may be installed upon any Lot if any part of the system is visible from another Unit or is visible by a person six feet tall standing upon any part of another Lot or the Common Area. For the purposes of this section, "solar energy system" means a system that produces electric energy solely by the use, as a primary energy source, of sunlight.
