(Pursuant to Utah Code Ann. §57-1-46)



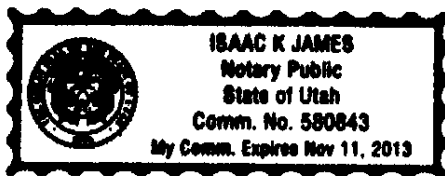
